

LIC Assistant Administrative Officer Exam (LIC AAO Exam)

Eligibility Condition: Minimum Age shall be 21 years (in completed years). Maximum age shall not be more than 30 years (in completed years)

Relaxations in upper age limit for SC/ST/OBC/ECO/SSRCO/Persons with Disabilities/Confirmed LIC employees shall be as under:

- 1. SC/ST 5 YEARS
- 2. OBC 3 Years
- 3. OH/VI(Gen) 10 YEARS
- 4. OH/VI(SC/ST) 15 YEARS
- 5. OH/VI(OBC) 13 YEARS
- 6. ECO/SSRCO (GEN) 5 YEARS
- 7. ECO/SSRCO (SC/ST) 10 YEARS
- 8. ECO/SSRCO (OBC) 8 YEARS

Educational Qualification: Bachelor's Degree in any discipline from a recognized Indian University/Institution

Emoluments and Benefits: Basic pay of Rs. 17240 /- per month in the scale of Rs.17240- 840(14) – 29000– 910(4) – 32640 (**Under Revision**) and other admissible allowances as per rules. Total emoluments at the minimum of the scale inclusive of House Rent Allowance & City Compensatory Allowance wherever admissible depending upon the classification of the city will be approximately Rs. 33,418/- per month in 'A' Class city. Other benefits are Defined Contributory Pension, Gratuity, LTC, Medical Benefit, Group Savings Linked Insurance (GSLI), Group Personal Accident Insurance, Group Insurance, Vehicle Loan (2-wheeler/4 wheeler) as per rules.

Probation: One year, extendable up to 2 years.

No other means/mode of applications will be accepted. Applicants are first required to go to the LIC's website www.licindia.in and click on the "Careers" to open the link.

Selection Procedure: Selection will be made on the basis of performance in the on-line test followed by a personal interview of short listed candidates and subsequent Pre-Recruitment Medical Examination.

On-line Test: On-line test will be of objective type, multiple choice of 120 minutes (2 hrs) duration comprising of the following:

Penalty for Wrong Answers: There will be a penalty for wrong answers marked in the Objective Tests. For each question for which a wrong answer has been given by the candidate, one fourth (1/4) of the marks assigned to that question will be deducted as penalty to arrive at corrected score. If a question is left blank, i.e. no answer is marked by the candidate, there will be no penalty for that question. Candidate **MUST** pass in each Section separately and should also obtain minimum marks in the aggregate to qualify for the interview. The minimum marks to be obtained in each Section and in the aggregate shall be decided by LIC of India. The marks obtained by the candidate in each Section and in the aggregate shall be arrived at after deduction of the marks for wrong answers. Decision of the Corporation in this regard shall be final and binding on the candidates. Appearing in the online examination or mere pass in the online examination shall not vest any right in a candidate to be called for Personal Interview.

Interview:

I. The Corporation reserves the right to fix the minimum eligibility standards in order to restrict the candidates to be called for interview, commensurate with number of vacancies and also the minimum qualifying marks to qualify in the interview. Candidates who do not obtain the minimum qualifying marks as decided shall be excluded from further selection process. The decision of the Corporation in this regard shall be final and binding on the candidates and no correspondence will be entertained in this regard.

II. The number of candidates to be called for interview will be about three times the number of vacancies to be filled in subject to the availability of successful candidates in the online test and will be purely as per their ranking in their respective category. Candidates will have to obtain the minimum marks in the interview as will be decided by the Corporation.



III. Outstation candidates called for interview shall be entitled for re-imbursement of Second Class Ordinary to and fro Railway/Bus Fare by the shortest route from the place of residence to the place of interview to be restricted to the fare by Railway Second Class Sleeper including the Reservation charges.

IV. In case of similar marks of two or more candidates, the merit order of such group of candidates shall be as per the aggregate marks in online test and interview and further as per their additional post graduation qualification (i.e. the person with higher educational qualification will be placed higher in the merit order) and in case of further similarity in educational qualification merit order will be decided on the basis of age, (i.e. senior in age will be placed higher in merit order).

Pre-Recruitment Medical Examination: Shortlisted candidates will have to undergo a Pre Recruitment Medical Examination and if found medically fit, will be offered appointment.

LIC Apprentice Development Officers Exam (LIC ADO Exam)

LIC Apprentice Development Officer (LIC ADO) Job is primarily a sales supervision job. The selected candidates will be required to recruit agents, train them properly, and help the recruited agents to sell life insurance to maximum number of persons. They will also be required to give prompt after sales service to policyholders.

An Apprentice Development Officer will have to undergo Theoretical & Field Sales Training and on successful completion of apprenticeship and if found suitable for appointment to the service of the Corporation in accordance with the rules may be appointed as Development Officer on probation subject to conditions framed by the Corporation.

Remuneration: During the apprentice period, the candidate selected as Apprentice Development Officer will be paid a fixed amount as stipend per month as per rules of the Corporation. At present the amount of stipend is about Rs.19165/- per month, except in case of candidates selected from LIC Employees category.

On appointment as a Probationary Development Officer, basic pay of Rs. 11535/- per month (except for Employee category candidates) in the scale of 11535-700(2)- 12935-825(2) 14585-840(17)-28865 and other admissible allowances as per rules shall be payable. Total emoluments will be approximately Rs.22065/-. Other benefits include Gratuity, Defined Contributory Pension Scheme, LTC, Medical Benefit, Group Savings Linked Insurance (GSLI), Group Personal Accident Insurance, vehicle advance (2-wheeler/4-wheeler) as per rules and on confirmation in service, attractive performance linked Incentives.

Eligibility Conditions:

(a) Qualifications: Bachelor's Degree of a University in India

(b) Age: (i) The applicant shall have completed 21 years of age (in completed years) and not more than 30 years of age (in completed years)

How to Apply: Candidates are necessarily required to apply On-line through LIC's website under the heading "Careers" http://www.licindia.in/careers.htm. No other means/mode of applications will be



accepted. Applicants are first required to go to the LIC's website www.licindia.in and click on the "Careers" to open the link.

Selection Procedure: Selection will be made on the basis of on-line test followed by an Interview of candidates who qualify in the on-line test.

On-line Test: On-line test will be of objective type, multiple choice of two hours duration comprising of the following two papers:

1. Test of Reasoning and Numerical Ability.

2. General Knowledge, Current Affairs and English Language with Special emphasis on Grammar and Vocabulary.

Candidate MUST pass in each paper separately and should also obtain minimum marks in the aggregate of the two papers to qualify for the interview. The minimum marks to be obtained in each paper and in the aggregate shall be decided by LIC of India. The marks obtained by the candidate in each paper and in the aggregate shall be arrived at after deduction of the marks for wrong answers. LIC of India reserves the right to fix the minimum eligibility standard in order to restrict the number of candidates to be called for the On-line Test and/or Interview, commensurate with number of vacancies. Decision of the Corporation in this regard shall be final and binding on the candidates.

Interview: Successful candidate will be eligible to be called for an Interview. Candidate who does not obtain the minimum qualifying marks in the Interview shall be disqualified from further selection.

Medical Examination: Selected candidate will be appointed as Apprentice Development Officer subject to him/her being found medically fit by the Medical Examiner authorized by LIC for the purpose.

LIC Housing Finance Ltd. Assistant Exam

Eligibility:

(i) Graduate in any discipline from a recognized University/Board (with minimum 50% marks).

(ii) Age Limit: Between 21 years and 35 years

Selection Procedure: Selection will be made on the basis of On-line test followed by an Interview of candidates who qualify in the On-line test.

On-line Test: On-line test will be objective type, multiple choice of 2 Hours duration having the following sections:

The online examination will be in English language only. There will be penalty for wrong answers marked in the Objective Tests. For each question for which a wrong answer has been given by the candidate one fourth or 0.25 of the marks assigned to that question will be deducted as penalty to arrive at corrected score.
